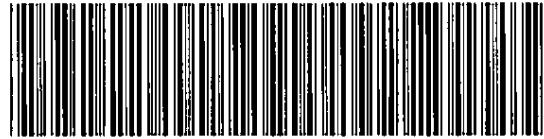

ARTICLE II: ADDRESS

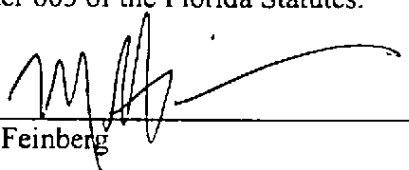

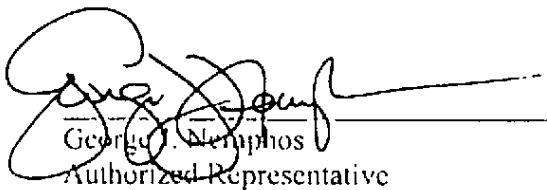

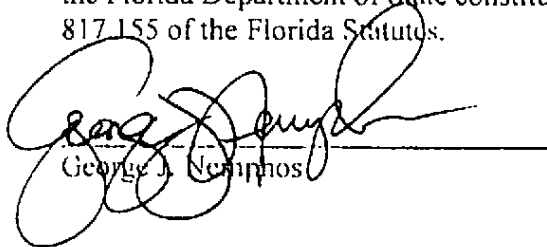
