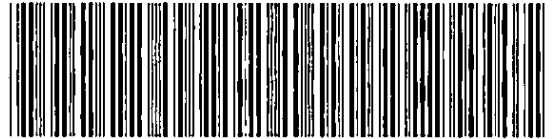

The Company shall be manager-managed, and the name and address of the manager authorized to manage and control the Company is as follows:

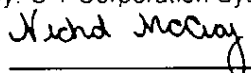
