**ARTICLES OF ORGANIZATION  
OF  
VALENTINE HOLDINGS INTERNATIONAL, LLC**

**SECTION 1 INTRODUCTION AND PRELIMINARY STATEMENTS**

The undersigned Organizer desires to form a limited liability company under the Laws of the State of Florida by delivering these Articles of Organization in duplicate to the Secretary of State of the State of Florida, in accordance with Florida Revised Limited Liability Company Act (the *Act*).

**SECTION 2 NAME**

The name of the limited liability company is Valentine Holdings International, LLC, a Florida limited liability company (*LLC*).

**SECTION 3 DURATION**

The LLC will perpetually exist from the filing date of these Articles of Organization with the Secretary of State of the State of Florida, unless dissolved according to law.

**SECTION 4 LLC'S PURPOSE**

The LLC's purpose is to engage in any lawful act or activity for which limited liability companies may be formed under the Act and all activities necessary or incidental to that purpose. The LLC has all the powers necessary or convenient to carry out its purposes, including the powers granted by the Act.

**SECTION 5 LLC'S PRINCIPAL OFFICE AND LOCATION OF RECORDS**

**SECTION 6 REGISTERED AGENT AND REGISTERED OFFICE**

**SECTION 7 OPERATING AGREEMENT AND AUTHORITY**

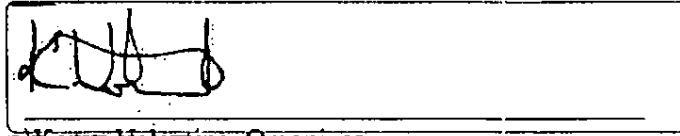

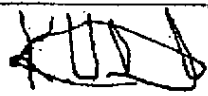
