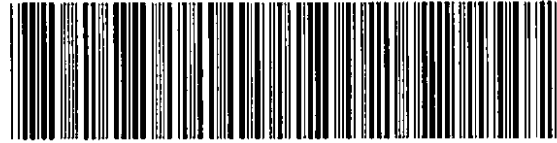

MANAGEMENT**


