**ARTICLES OF ORGANIZATION
OF
PRETTY LAKE FARM, LLC**

The undersigned hereby executes these Articles of Organization for the purpose of forming a limited liability company in accordance with the laws of the State of Florida.

ARTICLE I

Name

The name of this limited liability company (the "Company") shall be:

Pretty Lake Farm, LLC

ARTICLE II

Principal Office and Mailing Address

The address of the principal office of the Company shall be:

ARTICLE III

Registered Office and Registered Agent

The initial registered office of the Company shall be located at 117 N. Massachusetts Avenue, Lakeland, Florida 33801, and the initial registered agent of the Company at such office shall be Paula Dockery. The Company shall have the right to change such registered office and such registered agent from time to time, as provided by law.

ARTICLE IV

Manager

The Limited Liability Company shall be managed by one or more managers and is, therefore, a manager-managed limited liability company. The designation, authority, and duties of the Manager shall be as set forth in the Operating Agreement of the Limited Liability Company.

ARTICLE V

Operating Agreement

The power to adopt the Operating Agreement of the Company, to alter, amend or repeal the Operating Agreement of the Company, or to adopt a new Operating Agreement, shall be vested in the members of the Company. The Operating Agreement of the Company shall be for the governance of the Company and may contain any provisions or requirements for the management or conduct of the affairs and business of the Company, provided the same are not inconsistent with the provisions of these Articles of Organization or contrary to the laws of the State of Florida or of the United States.

ARTICLE VI

Amendment of Articles of Organization

The Company reserves the right to amend, alter, change or repeal any provisions contained in these Articles of Organization in the manner now or hereafter prescribed by statute, and all rights conferred upon the members herein are subject to this reservation.
