RESTRICTIONS ON MEMBERSHIP

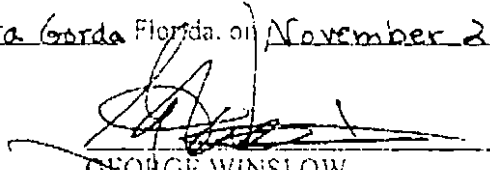
The Member shall have the right to admit new members by majority consent. Contributions required of new members shall be determined as of the time of admission to the limited liability company.

MEMBERS' RIGHTS TO CONTINUE BUSINESS

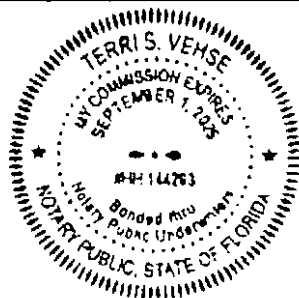

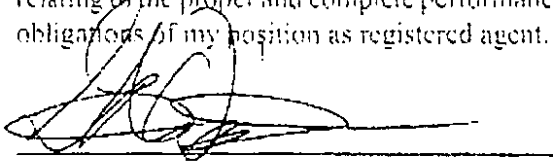
