

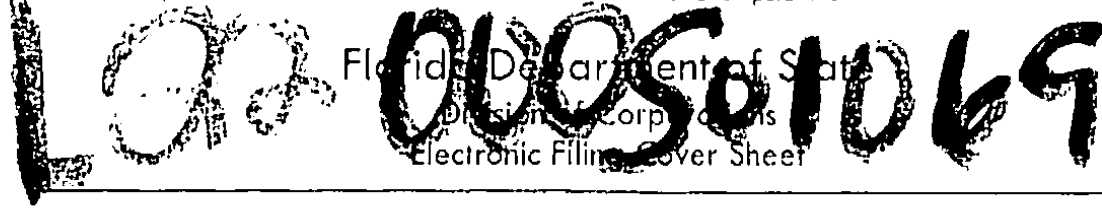


ARTICLE VI

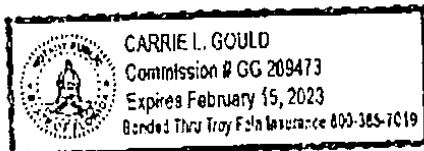



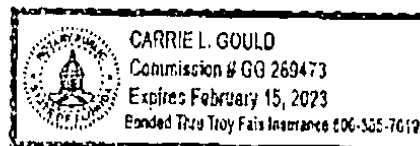
