
ARTICLE VI PROPERTY

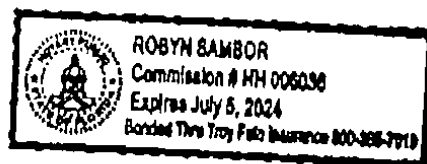

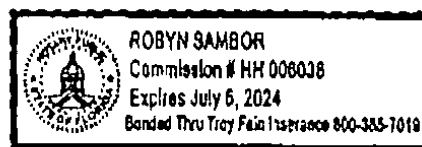
