**ARTICLES OF ORGANIZATION
OF

**ARTICLE I
NAME**

The name of this limited liability company is Hotchacha, LLC, a Florida limited liability company (the "Company").

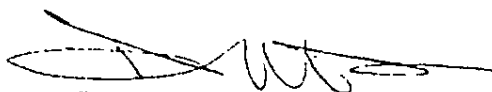
ARTICLE IX
