**ARTICLES OF ORGANIZATION
OF
CONDEV YOUNG PINE II, LLC**

ARTICLE I - NAME


**ARTICLE III - CERTIFICATE OF DESIGNATION OF

The effective Date for the Company shall be the **date of filing** with the State of Florida Division of Corporations.


