**ARTICLES OF ORGANIZATION  
OF  
BAYHEAD ESTATES II, LLC,  
a Florida limited liability company**

The undersigned organizer and authorized representative of a limited liability company to be formed under the Florida Limited Liability Company Act, as amended (the "*Act*"), does hereby certify that the persons so identified herein have associated themselves together for the purpose of forming a limited liability company (the "*Company*") under the laws of the State of Florida, pursuant to the *Act*, and hereby sets forth the following Articles of Organization (these "*Articles*");

**ARTICLE I**

**NAME**

The name of the Company shall be: BAYHEAD ESTATES II, LLC.

**ARTICLE II**

**ADDRESS AND PLACE OF BUSINESS**

The principal place of business and the mailing address of this Company shall be 30545 Bayhead Road, Dade City, Florida 33523, and such other place or places as may be designated by the Manager(s) from time to time.

**ARTICLE III**

**PERIOD OF DURATION**

The period of duration of the Company shall be perpetual.

**ARTICLE IV**  
**GENERAL POWERS**

The Company is formed for the purpose of conducting and undertaking, and shall have the power to conduct and undertake, any and all activities and actions authorized under the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes.

**ARTICLE V**  
**MANAGEMENT**

All powers of the Company shall be exercised by or under the authority of the manager and, except as otherwise provided in the operating agreement of the Company, if any ("*Operating Agreement*"), the business and affairs of the Company shall be managed by or under the direction of the manager. The initial Managers of the Company shall be **Kevin M. Steele** and **Michelle C. Steele**, acting together or independently, whose mailing address is 30545 Bayhead Road, Wesley Chapel, Florida 33543 and whose physical address is 30545 Bayhead Road, Wesley Chapel, Florida 33543.

**ARTICLE VI**  
**OPERATING AGREEMENT**

The members of the Company may adopt an operating agreement pertaining to the regulation, management, and other affairs of the Company (previously defined as the "Operating Agreement"), provided that such Operating Agreement shall not be inconsistent with these Articles of Organization or with the laws of the State of Florida. The Operating Agreement may be repealed or altered only in the manner now or hereafter prescribed therein, consistent with the laws of the State of Florida.

**ARTICLE VII**  
**REGISTERED OFFICE AND REGISTERED AGENT**




