# ARTICLES OF ORGANIZATION OF BAYHEAD ESTATES II, LLC, a Florida limited liability company

#### ARTICLE 1

NAME

The name of the Company shall be: BAVHEAD ESTATES H, LLC.

The Operating Agreement may be repealed or aftered only in the manner now or hereafter prescribed therein, consistent with the laws of the State of Florida.
