**ARTICLES OF ORGANIZATION
OF

The undersigned, William Norville Wilson II, a natural person competent to contract and an authorized representative of William Norville Wilson II, LLC, hereby presents these Articles of Organization as the Articles of Organization of William Norville Wilson II, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I – NAME

The name of the limited liability company is William Norville Wilson II, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II – PRINCIPAL OFFICE ADDRESS

ARTICLE III – PURPOSE AND POWERS

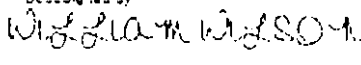
ARTICLE VI – MANAGEMENT

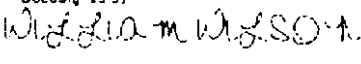
