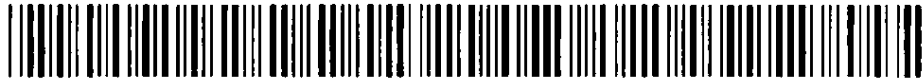

ARTICLES OF ORGANIZATION OF CDSIX, LLC

The undersigned, Eugene Phillip Stutts, a natural person competent to contract and an authorized representative of CDSix, LLC, hereby presents these Articles of Organization as the Articles of Organization of CDSix, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I – NAME

The name of the limited liability company is CDSix, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II – PRINCIPAL OFFICE ADDRESS

The Company shall be managed by one or more managers in accordance with the terms of the Operating Agreement for the Company. The names and addresses of the initial managers of the Company are as follows:




