

**ARTICLES OF INCORPORATION  
OF  
W&P IC-DISC, INC.**

These Articles of Incorporation (these "Articles") of W&P IC-DISC, INC., are being executed and filed by the undersigned, as the incorporator of the corporation, under the Florida Business Corporation Act (Florida Statutes, Chapter 607) (the "Act") and hereby adopts the following:

ARTICLE I – Name:

W&P IC-DISC, INC. (the "Corporation")

ARTICLE II – Principal Office:

The principal street and mailing address of the Corporation is 9375 N.W. 117 Avenue, Miami, Florida 33178.

ARTICLE III – Purpose:

The purpose for which this Corporation is formed is to engage in any lawful act or activity for which a corporation may be organized under the Act.

ARTICLE IV – Shares:

The aggregate number of shares of stock that the Corporation is authorized to issue and have outstanding at any time shall be One Thousand (1,000) shares of Common Stock, \$2.50 par value. ARTICLE V – Duration:


The duration of the Corporation shall be perpetual.
