**ARTICLES OF ORGANIZATION
OF
VERKLARTE NACHT LLC**

The undersigned, being the manager, desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 605, Florida Statutes, does hereby adopt the following Articles of Organization:

**ARTICLE I
NAME**

The name of the limited liability company is Verklarte Nacht LLC (the "Company").

**ARTICLE II
ADDRESS**

The principal office and mailing address of the Company is 501 South Flagler Drive, Suite 220, West Palm Beach, Florida 33401.

**ARTICLE III
REGISTERED AGENT AND OFFICE**

ARTICLE V
DURATION AND CONTINUATION

The period of the Company's duration shall commence with the filing of these Articles of Organization with the Secretary of State, and shall continue perpetually, unless terminated (i) in accordance with the Company's Operating Agreement, or (ii) by the written agreement of a majority of ownership interest.

ARTICLE VI
PURPOSE

The purpose for which the Company is being formed is to engage in any activity or business permitted under the laws of the United States and the State of Florida.


ARTICLE VII
