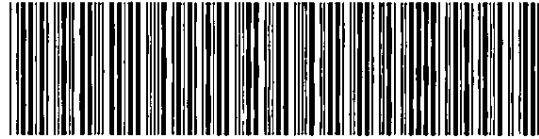

ARTICLE V - MANAGEMENT


