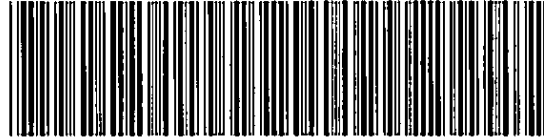


**ARTICLES OF CONVERSION






