# ARTICLES OF ORGANIZATION OF YU\_BIBLIOTEKA, LLC

#### ARTICLE I NAME: ADDRESS AND PLACE OF BUSINESS

The name of the Company shall be: YU\_BIBLIOTEKA, LLC

The address of the principal office and the mailing address of this Company shall be <u>18102</u> COURTNEY BREEZE DRIVE, TAMPA, FLORIDA 33647.

# ARTICLE II EFFECTIVE DATE AND DURATION; POWERS

These Articles of Organization shall be effective upon filing, and the Company shall thereafter have perpetual duration.

The Company is formed for the purpose of conducting and undertaking, and shall have the power to conduct and undertake, any and all activities and actions authorized under the Florida Revised Limited Liability Company Act, Chapter 605, *Florida Statutes* (the "Act").

# ARTICLE III MANAGEMENT

The Company shall member-managed, and <u>MIRA POPOVIC</u> is designated as the <u>AUTHORIZED MEMBER</u>, 18102 COURTNEY BREEZE DRIVE, TAMPA, FLORIDA 33647. <u>MIRA POPOVIC</u> is also appointed as <u>PRESIDENT</u> of the Company. Any person serving as an Authorized Member or in one of the specified officer positions may sign on behalf of the Company, and third parties may rely on such officer's signature without need for further investigation.

## ARTICLE IV REGISTERED OFFICE AND REGISTERED AGENT

The street address of the Company's initial registered office in Florida is 18102 COURTNEY BREEZE DRIVE, TAMPA, FLORIDA 33647, and the name of its initial registered agent is MIRA POPOVIC. The Company may change its registered office or its registered agent or both by filing with the Department of State of the State of Florida a statement complying with Section 605.0113. Florida Statutes.

#### ARTICLE V ACKNOWLEDGMENT

The Member of the Company, through its undersigned authorized representative, does hereby certify that the foregoing constitutes the Articles of Organization of YU\_BIBLIOTEKA, LLC. These Articles of Organization may be amended from time to time by consent of the Members holding a majority of the voting interests of the Company, or otherwise in the manner now or hereafter prescribed in the Company's Operating Agreement.
