ARTICLE I
NAME; ADDRESS AND PLACE OF BUSINESS

The name of the Company shall be: YU_BIBLIOTEKA, LLC

The address of the principal office and the mailing address of this Company shall be 18102 COURTNEY BREEZE DRIVE, TAMPA, FLORIDA 33647.

ARTICLE II
EFFECTIVE DATE AND DURATION; POWERS

These Articles of Organization shall be effective upon filing, and the Company shall thereafter have perpetual duration.

The Company is formed for the purpose of conducting and undertaking, and shall have the power to conduct and undertake, any and all activities and actions authorized under the Florida Revised Limited Liability Company Act, Chapter 605, *Florida Statutes* (the "Act").

ARTICLE III
MANAGEMENT

The Company shall member-managed, and MIRA POPOVIC is designated as the AUTHORIZED MEMBER, 18102 COURTNEY BREEZE DRIVE, TAMPA, FLORIDA 33647. MIRA POPOVIC is also appointed as PRESIDENT of the Company. Any person serving as an Authorized Member or in one of the specified officer positions may sign on behalf of the Company, and third parties may rely on such officer's signature without need for further investigation.

REGISTERED OFFICE AND REGISTERED AGENT

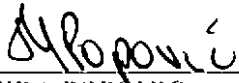
