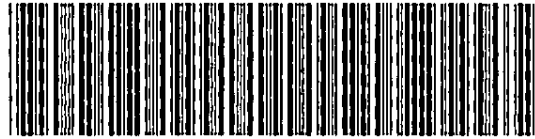

**ARTICLE VIII - REGISTERED OFFICE AND REGISTERED AGENT**

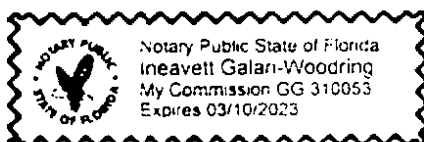

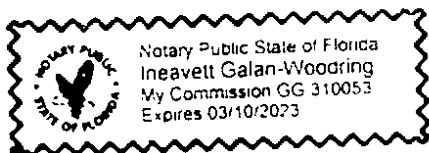

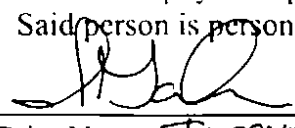
