To correct this issue, I was instructed that I must dissolve the incorrect name and refile with the new business name. As instructed, the dissolution has been approved and the business has been refiled as an LLC on 12/16/2022.

The new business name has been registered with Sunbiz.org as ***Recovery from Society LLC***, but has since been denied, as the name is too similar to the original filing. I have been instructed by two representatives to submit this affidavit, in hopes to expedite the dissolution of the Recovery from Society Inc, and allow the name Recovery from Society LLC, to be used. I do have an active business, so I hope that this matter can be resolved as soon as possible, to prevent any concerns with the business.
