ARTICLE I - NAME

ARTICLE V - REGISTERED OFFICE AND AGENT


The initial registered agent of the Company is James E. Pierce, and the initial address for that registered agent is 3570 Preserve Drive, Miramar Beach, Florida 32550.

The Company shall be managed by one or more managers in accordance with the terms of the Operating Agreement for the Company. The name and address of the initial manager of the Company is as follows:


