4. Place of Principal Office. The mailing and street address of the Company's principal office is 905 Mariner Way, Tampa, FL 33602.

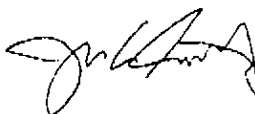
