As president of Dinka Service Corp., Federal Identification Number 65-0155349, I am submitting the company's 1998 Profit Corporation Annual Report and a check for \$150. I know that the report is filed after the initial deadline of May 1, 1998 and that the annual fee is \$550 for submissions after that date.

Please be advised that the filing is late because it was addressed and mailed to an incorrect address to a location in Hamburg, New York.
