**ARTICLES OF ORGANIZATION
OF

The undersigned, Melissa Suzanne Briscoe, a natural person competent to contract, hereby presents these Articles of Organization of SUZIE BRISCOE LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

ARTICLE V - REGISTERED OFFICE AND AGENT


