The undersigned, Azima Rasiwala, a natural person and an authorized representative of Azima Rasiwala, PLLC, hereby presents these Articles of Organization as the Articles of Organization of Azima Rasiwala, PLLC, a professional limited liability company formed under the provisions of Chapter 605 and Chapter 621, *Florida Statutes*.

ARTICLE I – NAME


ARTICLE VI – MANAGEMENT


