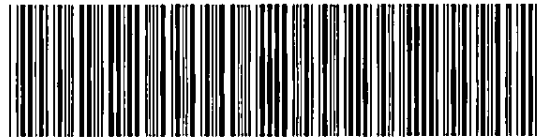

Pursuant to the Provisions of the Florida Statutes, the undersigned organizer hereby adopts the following Limited Liability Company Articles of Organization.

ARTICLE I
NAME

The name of the limited liability company is **LIDDON FURNITURE & HOME DECOR, LLC** (the "Company").

ARTICLE II
DURATION

The Company shall have a duration from the date of organization until it is dissolved and its affairs wound up prior to that date in accordance with the Florida Limited Liability Company Act (the "Act").

ARTICLE III

The purpose for which the Company is formed is to own and operate a furniture and home decor business, and otherwise deal in real estate and do all activities associated therewith, and to engage in any other lawful act or activity for which limited liability companies may be organized pursuant to the Act. Upon the unanimous written consent of the members, the Company may permit the admission of additional members and the terms and conditions of their admission shall be set forth in the Company's Operating Agreement.


**ARTICLE VII
