ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION OF PRIME MED HEALTH CONSULTING SERVICES LLC

Pursuant to the provisions of Section 605.0202, Florida Statutes, PRIME MED HEALTH CONSULTING SERVICES LLC, a Florida limited liability company (the "Company"), hereby adopts the following amendments to its Articles of Organization:

1. The name of the Company is PRIME MED HEALTH CONSULTING SERVICES LLC.

2. The Articles of Organization of the Company were filed on January 3, 2023, effective January 5, 2023 and assigned document number L.23000005691.

3. The sole Member of the Company has elected by written action dated May 26, 2023 to bring the company within the provisions of Chapter 621, Professional Service Corporation and Limited Liability Company Act.

4. Accordingly, Article I of the Articles of Organization is hereby amended as follows:

<u>"ARTICLE I</u>

The name of the Limited Liability Company is: PRIME MED HEALTH CONSULTING SERVICES PLLC."

5. Article VI is hereby added to the Articles of Organization to provide a statement of purpose as follows:

"ARTICLE VI

The purpose of the Limited Liability Company is to render medical services and medical consulting services."

6. Except as amended hereby, the Articles of Organization of the Company shall remain in full force and effect.

IN WITNESS WHEREOF, the undersigned, being the sole Member of the Company, has caused these Articles of Amendment to Articles of Organization to be executed on behalf of the Company this 26th day of May, 2023.
