**ARTICLES OF ORGANIZATION
OF

The undersigned, Scott A. Remington, competent to contract and an authorized representative of BUILD A BRAIN, BUILD A LIFE, BUILD A COMMUNITY, LLC, hereby presents these Articles of Organization as the Articles of Organization of BUILD A BRAIN, BUILD A LIFE, BUILD A COMMUNITY, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is BUILD A BRAIN, BUILD A LIFE, BUILD A COMMUNITY, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

The initial mailing address and principal address of the Company is 350 W. Cedar Street, Suite 300, Pensacola, Florida 32502. The Company's mailing address and principal office may hereafter be at such other place or places as its members from time to time may determine.

ARTICLE III - PURPOSE AND POWERS
