AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF HAN IT SOLUTIONS, LLC

This Amended and Restated Articles of Organization amend and restate in their entirety the Articles of Organization initially filed on January 5, 2023 and assigned Florida document number 1.23000009827 for the formation of the Company. The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act (the "Act") of the State of Florida pursuant to Chapter 605 of the Florida Statutes hereby makes, acknowledges, and files the following Articles of Organization providing for the formation, rights, privileges, and immunities of limited liability companies for profit.

ARTICLE I NAME

The name of the limited liability company shall be HAN IT SOLUTIONS, LLC (the "Company").
