

#### **ASSIGNMENT OF MEMBERSHIP INTERESTS**

This Assignment of Membership Interests (the "Assignment") is made this day of December 2023, by and between Akram Ismail, an individual ("Transferor"), and Ahmed Abdelkader Kawser ("Transferee").

WHEREAS, the Transferor owns (33 1/3%) of the membership interests of SAYFEE INTERNATIONAL LLC, a Florida limited liability company, a Florida limited liability company ("the "Company");

WHEREAS, Transferor has agreed to transfer his shares of the membership interests to the Transferee and the Transferee has agreed to accept from Transferor 33 1/3% of the Transferor's membership interests in the Company (the "Interests");

WHERAS, Transferor's transfer of its ownership interest in the Company to Transferee is in consideration of a full and complete settlement and release of her duties and obligations as owner to the Company and the Members except as outlined herein;

Exclusive venue and jurisdiction for any and all actions brought by either party to this Assignment to enforce the terms hereof shall reside in Lake County Florida, and each party hereby irrevocably submits to the personal jurisdiction of the courts located in such county.
