## ASSIGNMENT OF MEMBERSHIP INTERESTS

Exclusive venue and jurisdiction for any and all actions brought by either party to this Assignment to enforce the terms hereof shall reside in Lake County Florida, and each party hereby irrevocably submits to the personal jurisdiction of the courts located in such county.
