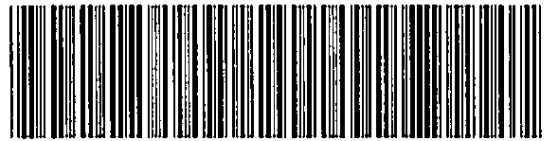



Pursuant to section 605.1045, F.S., an unincorporated business entity may convert to a Florida limited liability company.
