ARTICLES OF ORGANIZATION  
OF

Pursuant to the provisions of Chapter 505 of the Florida Statutes (the "Florida Revised Limited Liability Company Act"), the undersigned representative of the members, for the purposes of forming a Florida Limited Liability company, hereby adopts the following Articles of Organization:

ARTICLE 1  
NAME

The name of the company is MARFER CONSTRUCTION LLC, (the "Company").

ARTICLE 2  
DURATION AND PLACE OF BUSINESS
