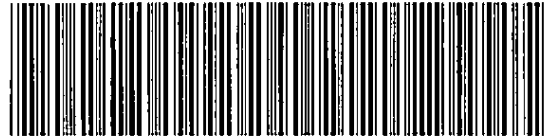

(a Florida Limited Liability Company)

The undersigned associate for the purpose of becoming a limited liability company under the laws of the State of Florida, providing for the formation, rights, privileges and immunities of limited liability companies for profit.

**ARTICLE I**

(Name and Principal Place of Business; E-mail address)


