**ARTICLES OF ORGANIZATION
OF
SARPCO DEVELOPMENT, LLC**

The undersigned, acting as the authorized representative of SARPCO DEVELOPMENT, LLC under the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, adopts the following Articles of Organization:

ARTICLE I - NAME:

The name of the limited liability company is SARPCO DEVELOPMENT, LLC (the "Company").
