To Whom It May Concern:

I recently became aware that when the referenced LLC was formed, I (James M Holtzman) was named as a 'Mgr.' of the LLC, as was my son (James M Holtzman, Jr), without our knowledge and/or consent. In addition, my office address was used for both the Principal address and the Mailing address of *IGY6 WET WORKS MARINE CONSTRUCTION LLC*, without my consent. Please note that the filing has my name as James M Holtzman, **Sr.** I am not, nor have I ever been known as a **Sr.** In addition, neither my son nor myself have any known ownership in *IGY6 WET WORKS MARINE CONSTRUCTION LLC*.


Upon learning of the creation of *IGY6 WET WORKS MARINE CONSTRUCTION LLC*, I requested that both my name and my sons name be removed, as well as, the use of my office address as their Principal and Mailing address, as we didn't want any ties to this firms financial or liability obligations. After repeatedly asking if an Amendment had been completed and sent to the Division of Corporations went unanswered, I completed and mailed an *Articles of Amendment to Articles of Organization* to the state on February 10, 2023. The document was received by the state on February 13, 2023, as verified with our tracking receipt. The \$25 filing fee check was deposited on February 14, 2023 and cleared our bank account on February 17, 2023.

In reviewing the *Sunbiz* website today, I noticed that LLC Amendments received between December 1<sup>st</sup> thru December 14<sup>th</sup> 2023 is what was currently being processed. I then called the state and spoke with a state representative, who advised that it could be several months before the *Articles of Amendment to Articles of Organization* is filed and the corrections noted in *Sunbiz*. The representative advised me to send a notarized letter to the state, requesting that it be noted that the initial filing was done without my consent and/or knowledge and we do not want to be held responsible for any financial and/or liability obligations associated with this LLC, prior to the corrections being made in *Sunbiz*.


