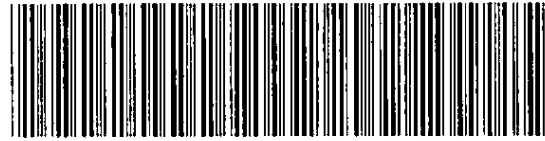

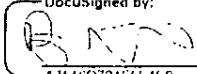
ARTICLE VI - Members Rights to Continue Business:

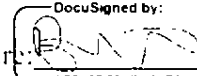
ARTICLE VII - Initial Registered Office and Registered Agent
