ARTICLES OF ORGANIZATION
OF
MIRAMAR ACQUISITION COMPANY, LLC

The undersigned, acting as the authorized representative of MIRAMAR ACQUISITION COMPANY, LLC under the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, adopts the following Articles of Organization:

ARTICLE I - NAME:
