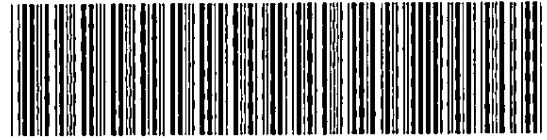

**ARTICLES OF ORGANIZATION
OF
BLUE PROVENCE OF NAPLES, LLC**

a Florida Limited Liability Company

The undersigned, being the duly authorized representative of the initial members of a limited liability company to be organized under the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, adopts and submits the following Articles of Organization for such limited liability company:

**ARTICLE I
NAME**

The name of the limited liability company is **BLUE PROVENCE OF NAPLES, LLC**, a Florida limited liability company (the "Company").

**ARTICLE II
PRINCIPAL PLACE OF BUSINESS**

DURATION**


The Company's duration shall be perpetual.


