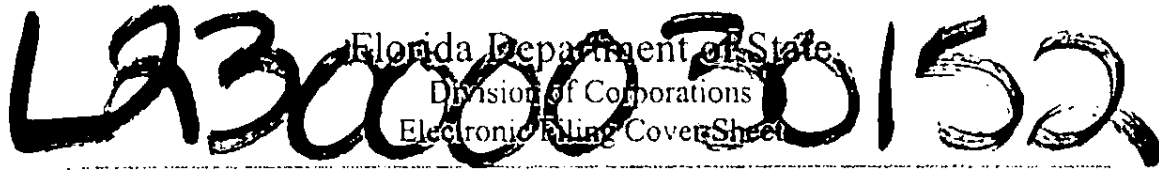

**AMENDED AND RESTATED ARTICLES OF ORGANIZATION
OF
GA SPIRITUAL WARRIOR PROPERTIES, LLC**

The undersigned submits the following Amended and Restated Articles of Organization pursuant to the authority and provisions of Section 605.0202 of the Florida Revised Limited Liability Company Act:

FIRST: The name of the Limited Liability Company filing these Amended and Restated Articles of Organization is GA SPIRITUAL WARRIOR PROPERTIES, LLC.

The Articles of Organization for the Limited Liability Company were filed with the Corporations Division of the Florida Department of State on January 17, 2023, with an effective date of January 13, 2023, under Document No. L23000030152.

SECOND: These Amended and Restated Articles of Organization supersede and take the place of the existing Articles of Organization and any and all amendments thereto:

ARTICLE I. - NAME:

The name of the Limited Liability Company is GA Spiritual Warrior Properties, LLC

ARTICLE II. - PURPOSE:

The purpose of the Limited Liability Company is to acquire, own, maintain, lease, and otherwise manage real property, and perform any and all ancillary matters related thereto.

ARTICLE III. - DURATION:

The period of duration for the Limited Liability Company began with the filing of the original Articles of Organization with the Florida Department of State, and shall exist perpetually, unless sooner dissolved in accordance with the Operating Agreement of the Limited Liability Company or Florida law.
