The undersigned, being authorized to execute and file these Articles of Organization, hereby certifies that:

ARTICLE I. NAME

The name of the limited liability company is **DOING THIS TOGETHER HOLDINGS LLC** (the "Company").

ARTICLE VI. OPERATING AGREEMENT

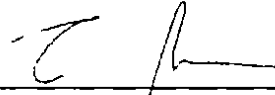
