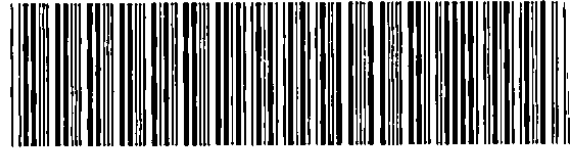



**ARTICLES OF ORGANIZATION

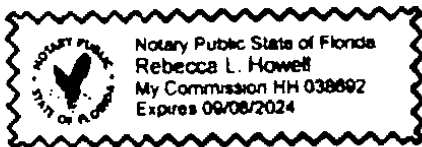

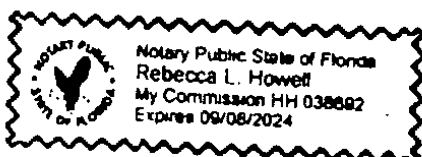
