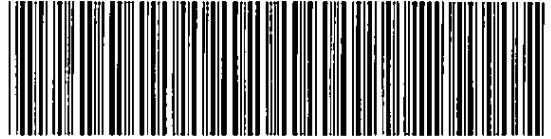

business at this time due to a lack of sales.




