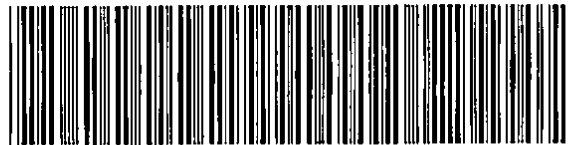

**ARTICLES OF ORGANIZATION
OF
JDS ORLANDO HOLDINGS LLC**

A Florida Limited Liability Company

The undersigned individual, acting in his capacity as organizer of JDS ORLANDO HOLDINGS LLC as contemplated by the Florida Revised Limited Liability Company Act, Chapter 605, Fla. Stat., adopts the following Articles of Organization:

ARTICLE I – NAME

The name of this limited liability company is JDS ORLANDO HOLDINGS LLC (the “Company”).

ARTICLE II – PRINCIPAL OFFICE / MAILING ADDRESS
