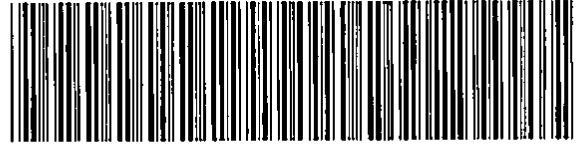

The street and mailing address of the Company's principal office is 1000 South Pointe Drive, Suite 2803, Miami Beach, FL 33139.




