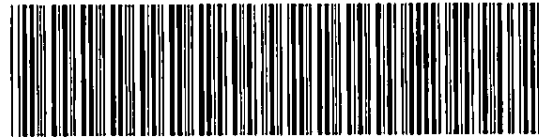

**ARTICLES OF ORGANIZATION
OF

I, the undersigned subscribe to these Articles of Organization, a natural person competent to contract, herby form an organization under the laws of the State of Florida.

**Article I
Organization Name**

The name of this processional service organization is **GRAB BAGS LLC**. The said address is **204 SW 16TH COURT - UNIT D, FT. LAUDERDALE, FL 33315**.

**Article II
Nature of Business**

Grab Bags LLC will operate as a purchase agent for companies and individuals wishing to avail themselves of such services. In addition, Grab Bags LLC will operate as a merchant buyer and consultant to existing businesses as well as startups. Company will act in its professional capacity to acquire merchandise as stipulated by the client or in some cases at the company's discretion based on suitability and availability. In addition, the company may also invest in real estate for its own gain. Company may build new structures that consist of spec homes, and rental properties for the purpose of yielding a profit for its owners.

Company from time to time will solicit international contracts from individuals and companies. **GRAB BAGS LLC** will reserve the right to partner with other entities to secure contractual arrangements with municipalities, state, and federal government. This would be to fulfill its primary focus of securing facility maintenance and facility management agreements. A division of this company may engage in other activities to increase its revenue for the partners.

This company will also engage in any other activities or business permitted under the laws of the United States of America.

To manufacture, purchase or otherwise acquire, and to own, mortgage, pledge, sell, assign, transfer, manage, or otherwise dispose of, and to invest in, trade in, deal in and with goods, wares merchandise, real and personal property, and services, of every class, kind and description except that it is not to conduct a banking, safe deposit, trust, insurance, surety, express, railroad canal, telegraph, telephone, or cemetery company, a building and loan association, mutual fire insurance association, cooperative association, fraternal benefit society, state fair or exposition. To contract debts and borrow money, issue and sell or pledge bonds, debentures, notes or other evidence of indebtedness and execute such mortgages, transfer of property, or other instruments to secure the payment of corporate indebtedness as required.

To produce corporate assets of any other company property and engage in the same or other character of business.

To guarantee, endorse, purchase, hold, sell, transfer, mortgage, pledge, or otherwise acquire or dispose of the initial capital investment, or any bonds, securities, or other evidence or indebtedness created by other companies of the State of Florida, or any other state or government, and while owner of such capital to exercise all the rights, powers, and privileges or ownership, including the right to vote such capital.

**ARTICLE XI
AMENDMENT**

The Articles of Organization may be amended in the manner provided by law. Every Amendment shall be approved by a majority vote of the shareholders based on most of the stock entitled to vote thereon, unless all the shareholders sign a written statement manifesting their intention that a certain amendment of these Articles of Organization is made.

**ARTICLE XII
CUMULATIVE VOTING**

The shareholders of the organization shall be allowed to vote their shares cumulatively so as to give one candidate as many votes as the number of directors to be elected, multiplied by the number of his shares, to distribute them among as many candidates as he may wish. Notice in writing must be given by any shareholder to the manager of said organization not less than twenty-four (24) hours prior to the time set for the holding of a shareholders' meeting, for the electing of directors that said shareholder intending to cumulate his vote at said election.

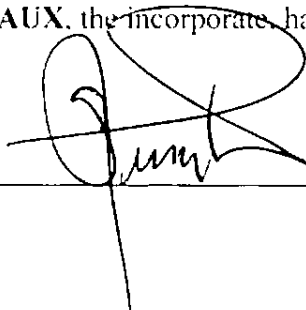
**ARTICLE XII

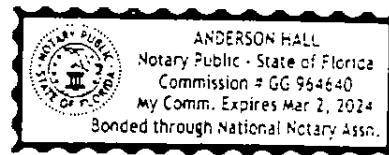
