ARTICLES OF ORGANIZATION

The undersigned, acting as the authorized representative, does hereby certify that the person identified herein has formed a limited liability company (the "Company") under the laws of the State of Florida and under the Florida Revised Limited Liability Company Act, Chapter 605, *Florida Statute* amended (the "Act"), and pursuant to the Act hereby sets forth the following Articles of Organization:

ARTICLE I: NAME


ARTICLE IV: MANAGEMENT


