ARTICLE V: TERM OF EXISTENCE

This LLC is to exist perpetually, commencing upon filing and acknowledgment hereof as provided by Florida State Statute Chapter 605.

ARTICLE VI: PREEMPTIVE RIGHTS

ARTICLE VIII: NATURE OF BUSINESS

ARTICLE IX: APPROVAL OF MEMBERS REQUIRED FOR MERGER

The approval of the members of this LLC to any plan of merger shall be required in every case, whether or not law requires such approval.

ARTICLE X: COMPENSATION OF MANAGERS

The members of this LLC shall have the exclusive authority to fix the compensation of managers of this LLC.

ARTICLE XI: INDEMNIFICATION

The LLC shall, to the fullest extent permitted by Florida Statutes Chapter 605, as the same may be amended and supplemented, indemnify any and all persons whom it shall have power to indemnify under said section from and against any and all of the expenses, liabilities or other matters referred to in or covered by said section, and the indemnification provided for herein shall not be deemed exclusive of any other rights to which those indemnified may be entitled under any member agreement, operating agreement, vote of members or disinterested managers or otherwise, both as

to action in his official capacity and as to action in another capacity while holding such office, and shall continue as to a person who has ceased to be a manager, officer, employee or agent and shall inure to the benefit of the heirs, executors and administrators of such a person.


ARTICLE XII: AMENDMENT

This LLC reserves the right to amend or repeal any provisions contained in these Articles of Organization or any amendment hereto, and any right conferred upon the members is subject to this reservation.
